1. Welcome to participants

2. Adoption of agenda

3. Approval of minutes and matters arising of last meeting

The minutes of the last meeting were adopted without modifications.

4. Update from the Action Chair

a Status of Action, including participating countries

24 COST countries participate to the SUSTAIN Action. In addition, Ukraine, a COST Near Neighbor Country, and Argentina, a country with reciprocal agreement, have joined the Action. Partners from Argentina can ask for additional funds to participate to meetings or training schools of the Action and STSMs involving partners from Argentina can profit from special funding.

b Promotion of gender balance and of Early Stage Researchers (ESR) From the 120 participants of the SUSTAIN Action 35 % are Women (30% in the MC, 45% in the core group) and 30% are ESRs (PhD 8 years or less). The promotion of gender balance and ESR participation are important objectives of the Action and will be criteria for the attribution of STSM grants and meeting participations. It was highlighted that from the 32 oral presentations at the annual conference 50% were from female scientists and 25% from ESRs.

c Non-COST applications to the Actions

María Eugenia Segretin (Laboratorio de Biotecnología Vegetal, INGEBI-CONICET, Argentina) is applying to join the action. María José Diéguez, (IGEAF – INTA, Buenos Aires – Argentina) and Lilya Pylypenko, National Academy of Agrarian Sciences, Kyiv, UKRAINE have joined the Action.

d. Action budget status

The working and budget plan for 2013/14 has been recapitulated

- Structure-guided investigation of Effector function and Effector recognition (SM).
- Industry/breeder workshops on pathogen-informed resistance breeding, engineering and monitoring.
- Workshop on intellectual property

The core group and potential local and scientific organizers will take up discussions initiated during the MC meeting and will make concrete suggestions for workshops & training schools before the end of the year to serve as a basis of the elaboration of the working plan for the next grant period.
